the global economy got off to a bumpy start this year but growth in 2015 and 2016 looks to be broadly on track projections for developing countries in 2014 have been down downgraded by 0 5 percentage points to 4 8 percent mainly reflecting weak first quarter growth in the us due to weather and the conflict in ukraine going forward growth is projected to firm to 5 3 and 5 5 percent in 2015 and 2016 supported by easy global financial conditions and rebounding exports as high income countries continue to recover under the influence of a reduced drag from fiscal consolidation and improving labor markets financial conditions will eventually tighten and when they do there is risk of further volatility most developing countries are in good fiscal and financial shape but where vulnerabilities remain countries need to tighten policy to reduce the potential impact of external shocks

overall growth for developing countries will be solid but not strong enough to generate the income and employment gains needed to eliminate poverty by 2013 as a result countries need to focus on structural reform in order to lift growth in and enduring and sustainable manner

in january 1976 raymond barre the first president of the geneva association and orio giarini its first secretary general founded the geneva papers on risk and insurance with the main goal of supporting and encouraging research in the economics of risk and insurance at that time research in the field of insurance was still embryonic and insurance was regarded as peripheral social activity when sustained economic growth gained traction the function of insurance gradually emerged as a key contributor to economic development by integrating uncertainty into economic theory and benefiting from the progress of both financial economics and decision theory research developed further in the field of insurance economics and risk management and is now prolific the geneva papers on risk and insurance undeniably contributed to this evolution and its impact on research in insurance has largely exceeded what its two founding members could have expected this volume is a special collection of papers celebrating 40 years

of the geneva papers on risk and insurance the collection looks back at the storied history of the geneva papers on risk and insurance and features papers from some of the esteemed authors who have contributed to the journal in its lifetime this collection of papers highlights just a few of the many themes addressed in the papers published by the journal since it was created nevertheless the selection exemplifies the richness and variety of topics the field of insurance covers

macro regional strategies seek to improve the interplay of the eu with existing regimes and institutions and foster coherence of transnational policies drawing on macro regional governance and europeanization this edited volume provides an overview of processes of macro regionalization in europe displaying evidence of their significant impact

institutions that are making these important decisions in the field of economic and monetary policy this book principally examines the mechanisms for political and legal accountability in the emu and the banking union it examines the implications that the reforms of eu economic governance have had for the locus and strength of executive power in the union as well as the role of parliaments and other political fora and courts in holding the institutions acting in this area accountable for the exercise of their tasks it further sets out several proposals regarding transparency accountability and legitimacy in the emu

response to lack of private solutions banks requirement to provide a minimum amount of eligible liabilities safety buffers to protect resolution need to be resolvable in a worst case leverage and liquidity ratios forced mergers market spillover effects of recovery planning group recovery planning effects of foreign law contracts and assets write down of capital instruments and special problems of cross border restructuring the presentation is enhanced by a comparative dimension which includes reference to united states and other national developments and a full scale analysis of switzerland's regulatory response to the crisis given that a full seamless global system of bank recovery and resolution has not yet been found and that major banks are global players headquartered in different jurisdictions and even different continents this book will greatly assist in the work of practitioners who must deal with cases involving international banking under the prevailing status quo its usefulness to officials and academics in international banking and finance law and policy who are working towards a global solution is of incalculable value

this is a history of 1968 written from a new perspective that of center right student activists in west germany based on oral history interviews and new archival sources it examines the ideas experiences and repertoires of center right students in this age of protest writing these activists back into the history of 1968 and its afterlives including student protest cultural revolt internationalism debates about left wing violence and the terror of the red army faction the memory wars of the 1980s and beyond reveals that this was a broader more versatile and ultimately more consequential phenomenon than the traditionally narrower focus on a left wing minority allows other 68ers demonstrates that we need a more nuanced history of the 1968 generation and of generational conflict during these years student activists comprised individuals from across the political spectrum who often had very different ideas about what kind of a society they envisaged and how to address the shortcomings of west german democracy 1968

was a moment of intense political conflict but it also played out within the student body and nurtured contrasting identities this book shows that the center right involvement in 1968 had real consequences many of the protagonists of this book would go on to pursue high profile political careers and leave their mark on west german political culturey other 68ers therefore sheds fresh light on how west germany s center right dealt with the crisis of hegemony and political identity it experienced in the wake of 1968 how it coped with generational change how it transformed and modernized after losing power at the national level for the first time in 1969 and how it managed to re emerge so successfully in the 1980s
