in this the second edition of a social history of england francois bédarida has added a new final chapter on the last fifteen years the book now traces the evolution of english society from the height of the british empire to the dawn of the single european market making full use of the annales school of french historiography bédarida takes his inquiry beyond conventional views to penetrate the attitudes behaviour and psychology of the british people

wages and earnings is a review of statistical sources both official and non official on wages and earnings in britain the non official sources of data relate mostly to salary statistics while most of the official data are produced by the department of employment topics covered range from wage rates and salary scales to fringe benefits and labor costs the concepts of incomes earnings wages and salaries are also explained this book is comprised of eight chapters and begins with an overview of earnings as well as the concepts of wages and salaries the next chapter examines three official sources of wage rates time rates of wages and hours of work changes in rates of wages and hours of work and the gazette the reader is then introduced to the official and unofficial statistics on salary scales as well as salary surveys and official sources of earnings fringe benefits with the associated concept of total remuneration and employers labor costs are also discussed along with historical data on earnings and its components the final chapter evaluates the various statistical sources of wages and earnings and ends with a few recommendations this monograph will be a valuable resource for economists and economic policymakers as well as government officials

the political economy of imperial relations offers a much needed historical and theoretical intervention into the relationship between britain and malaya after the second world war it challenges existing accounts and details a strong continuity in this relationship from 1945 until 1960

a comprehensive look into early professional football this biography of everton and liverpool s founding father john houlding breaks new ground by addressing the important role of football club ownership in the early history of the game football supporters the world over are aware of the great rivalry that exists between the two giants of merseyside football everton and liverpool this rivalry was created out of a split within everton fc that gave rise in 1892 to liverpool fc the two clubs subsequently went on to dominate the english game amassing twenty seven english top flight titles between them more than any other city in the country what isn t as well known is that one man was responsible for the rise of both clubs former lord mayor of liverpool john houlding in the man who created merseyside football john houlding founding father of liverpool and everton

David Kennedy recounts the sporting legacy of Houlding a brewer and conservative politician Houlding was a polarising yet fascinating figure his financial input first at Everton football club and then at Liverpool football club provided the launch pad for the establishment of two nationally and internationally known sporting organizations by the time of his death in 1902 both clubs had reached the pinnacle of the English game and Houlding's place as the founding father of professional football in Merseyside was assured more than just a football biography the man who created Merseyside football also details the many other aspects of Houlding's life a family man businessman and local politician with parliamentary aspirations his business and political life in fact became entangled in dramatic fashion with the Liverpool football scene on more than one occasion the complete story of this captivating and influential individual is finally told for the first time in this book in full and wonderful detail

In the momentous period barely 30 years covered by this systematic reference guide the Edwardian world was transformed unrecognisably through war technological progress and social change into the nuclear age it saw the coming of mass democracy the apogee of empire the depression the threat of fascism the development of suburban society and as yet scarcely understood the end of Britain's international hegemony Andrew Thorpe's superb contribution to the Companions series illuminates all this and much else it will be indispensable to anyone interested in the history and politics of modern Britain

Based on an industrial relations case study conducted in a British steel plant in the North East coast iron and steel industry this book first published in 1976 is an account of the application of sociological concepts and ideas to the process of social relations between employer and employee and between all types of workers in industrial organisations

This much needed study of the British Empire Exhibition reveals durable persistent connections between empire and domestic society in Britain during the interwar years it demonstrates that the exhibition was a marker of how by 1924 imperial relations were increasingly likely to be shaped by forces located on the colonial periphery

Based on an investigation of trade union structures and the earnings and intermarriage of manual workers in the cotton and engineering industries in Rochdale between 1856 and 1964 argues that an internal division of the manual working class around the axis of skill was a central feature of labour market and work relations in Britain between the mid nineteenth century and the mid 1960s

The income velocity of money an inverse measure of the demand for money balances is the ratio of the money value of income to the average money stock that the public excluding banks holds in a given period why the magnitude of that ratio has changed over time is the subject of Michael D Bordo and Lars Jonung's classic study originally published as *The Long Run Behavior of the Velocity of Circulation* supported by statistical data econometric estimation techniques and meticulous historical analysis this work describes in an international setting how slow moving economic social and political forces interact with the decisions households and firms make about how much money to hold annual time series of velocity for several countries from the late

nineteenth century to the late twentieth century display a u shaped pattern existing theories can explain each section of the velocity curve the falling flat and rising parts but the overall pattern is not consistent with any one theory here the authors put forth a comprehensive explanation for this behavior over time their theory is largely an extension of the approach of knut wicksell the swedish economist who stressed the role of substitution between monetary assets this approach which emphasizes institutional variables is incorporated into the arguments for the traditional long run money demand velocity function four types of empirical evidence strongly support the authors theory econometric studies of the long run velocity function for several countries a cross section study of approximately eighty countries in the postwar period a case study of the swedish monetization process in the fifty years before world war i and an examination of the time series properties of velocity demand for money suggests that institutional factors as opposed to real income play a greater role in velocity than previously thought and these institutional factors have a major impact on monetary policy this is a book that will prove of great value to economists monetary strategists and policymakers

how did britain transform itself from a nation of workhouses to one that became a model for the modern welfare state the winding road to the welfare state investigates the evolution of living standards and welfare policies in britain from the 1830s to 1950 and provides insights into how british working class households coped with economic insecurity george boyer examines the retrenchment in victorian poor relief the liberal welfare reforms and the beginnings of the postwar welfare state and he describes how workers altered spending and saving methods based on changing government policies from the cutting back of the poor law after 1834 to parliament s abrupt about face in 1906 with the adoption of the liberal welfare reforms boyer offers new explanations for oscillations in britain s social policies and how these shaped worker well being the poor law s increasing stinginess led skilled manual workers to adopt self help strategies but this was not a feasible option for low skilled workers many of whom continued to rely on the poor law into old age in contrast the liberal welfare reforms were a major watershed marking the end of seven decades of declining support for the needy concluding with the beveridge report and labour s social policies in the late 1940s boyer shows how the liberal welfare reforms laid the foundations for a national social safety net a sweeping look at economic pressures after the industrial revolution the winding road to the welfare state illustrates how british welfare policy waxed and waned over the course of a century

first published in 1986 this book explores developments in the cinema sport holidays gambling drinking and many more recreational activities and situates working class leisure within the determining economic and social context in particular the inventiveness of working people at play is highlighted drawing on an extensive range of source material the book has a wide general appeal and will be useful to those professionally concerned with leisure as well as teachers and students of social history and all those interested in the patterns of working class life in the past

the role of the state in capitalist societies has been a bone of considerable contention among scholars the two

founding fathers of sociology held radically opposing views on this subject which were reflected in the numerous debates over subsequent decades to this day yet no answer has been found to the vexing question on whose side is the state in capitalist societies the author examines current theories and comparing Britain and Germany shows that they are unable to explain the contradictory social and industrial policies in these two countries during the twentieth century based on in depth archival and secondary sources the author offers an alternative theoretical framework one that focuses on the interactions among historical contingencies the global cultural context and political processes

this is a major study of economic policy making in Britain between the wars it provided the first full length analysis of the early development of fiscal policy as a tool of modern economic management the central question addressed is how Keynesian fiscal policies came to be adopted by the British government with particular attention paid to the role of the Treasury and to that of Keynes himself drawing extensively on unpublished documents hitherto untapped by economists or historians Roger Middleton challenges the widely held view of official economic thinking as an ill informed group of people holding the Treasury view in opposition to Keynes's prescriptions for deficient demand and mass unemployment instead he argues that acceptance of Keynesian economics during the second world war resulted from political and administrative factors as much as a conversion to Keynesian theory he investigates the form and impact of fiscal policy during the 1930s and through a constant employment budget analysis shows convincingly that at times of rising unemployment governments ignore at their peril the effects of automatic stabilizers upon budgetary stability historians and economists welcomed this fresh perspective on a debate of historical as well as contemporary importance towards the managed economy is essential reading for all those interested in the rise and fall of Keynesian demand management this classic text was first published in 1985

the intention of this book is to give a picture of the complex material that has been published in the field of social and economic statistics in western Europe although there are many guides bibliographies and reference books on special topics of this broad theme a general overview has been missing with this book I hope to fill this gap the frame of reference is a scientific one enabling and facilitating comparative social research on western Europe in some respect this book enlarges and updates the bibliography written by Peter Flora *Quantitative Historical Sociology* published in *Current Sociology* in 1975 in principle this guide is an annotated bibliography of the most important printed material in the field of official statistics the legitimacy of such an approach lies in the fact that even today printed statistics are the most important form of dissemination of statistical results although microcomputers CD-ROMs and the internet have changed this situation in any case a special section on statistical databases is included for every country describing the main databases of the statistical offices furthermore the internet address of each international or national statistical institute is provided in the introductory paragraph this enables the reader to get fast access to online databases and supplementary online information on statistics via the internet

this book provides the first single overview of Labour's electoral progress in Glasgow from its hesitant steps in

the shadow of liberalism to the moment it became the dominant party in the city in parliamentary and municipal politics the unfolding narrative is not one of uninterrupted progress but a more complex story of partial breakthroughs and setbacks labour's electoral challenge is detailed over forty years and focuses on local elections more than parliamentary this allows a broader and fuller picture to be presented rather than the narrower emphasis on the red clydeside period of the great war and immediately after the great war was the critical turning point after 1918 labour emerged from being a permanent minority to a position where it could genuinely seek to present itself as the major political voice in glasgow the nature of this transformation is identified as both the radicalising effect of the war itself and the attendant changes this provoked in labour's attitude to its actual and potential constituency unlike other studies of the franchise system the view expressed here is that the franchise was biased against the working class and this operated against labour however labour was effectively handicapped by its own ambivalence towards complete democracy fuelled by fear of the poor and belief in the reactionary tendencies of the existing female local electorate while the war resolved the franchise issue for labour in glasgow the party's own mobilisation over housing provided the means to appeal to the new female electorate

raising the red flag explores the origins of the british marxist movement from the creation of the social democratic federation to the foundation of the communist party it tells a story of rising class struggle the founding of the labour party the fight against world war one the russian revolution and the explosive year of 1919 the book also uses new archival sources to re-examine marxist organisations such as the british socialist party the socialist labour party and sylvia parkhurst's workers socialist federation above all this is the story of men and women who fought to liberate the working class from capitalism through socialist revolution

this is an account of how the daily lives of ordinary peoples were changed profoundly and permanently by these three momentous decades 1914 1945 often depicted in negative terms peter dewey finds a much more positive pattern in the wealth of evidence he lays before us his is a story of economic achievement and the emergence of a new sense of social community in the nation rather than a saga of disenchantment and decline

modern britain focuses on two major periods of british history the interwar period and postwar britain the authors compare and contrast developments in the two periods dealing with the themes of growth and welfare industry labour social policy the economy combining a narrative with a conceptual and analytic approach modern britain provides an end of century review of progress and decline and an essential background to current polemics and major issues of concern clearly structured and written this is an invaluable textbook for students of twentieth century british history

by offering a comparative institutional analysis of how state supported pensions for the elderly developed in britain canada and the united states ann shola orloff makes a profound contribution to understanding the growth of modern social welfare policies it is not enough orloff demonstrates to simply examine socioeconomic factors in the growth of the welfare state she argues that welfare policies are shaped as well by the political institutions and processes that are the legacy of state formation and expansion in given nations orloff explains why when and how poor relief was replaced by modern social insurance legislation and pensions for the elderly in the first three decades of the twentieth century she analyzes the long term social and political transformations that laid the basis for modern social politics the spread of waged work the development of new liberal ideologies and the expansion and transformation of state administrative capacities combining original historical research with the analysis of secondary sources orloff s work is an excellent example of the use of comparative and historical methods to answer questions about macropolitical transformation such as the origin of the welfare state the politics of pensions outlines an original interdisciplinary approach that will appeal to a wide variety of readers political sociologists interested in the state social workers and specialists in old age policy and comparative researchers of all disciplines engaged in research on the welfare state

the second world war is often seen as a period of emancipation because of the influx of women into paid work and because the state took steps to relieve women of domestic work this study challenges such a picture the state approached the removal of women from the domestic sphere with extreme caution in spite of the desperate need for women's labour in war work women's own preferences were frequently neglected or distorted in the search for a compromise between production and patriarchy however the enduring practices of paying women less and treating them as an inferior category of workers led to growth in the numbers and proportions of women employed after the war in many areas of work penny summerfield concludes that the war accelerated the segregation of women in inferior sectors of work and inflated the expectation that working women would bear the double burden without a redistribution of responsibility for the domestic sphere between men women and the state first published in 1984 this is an important book for students of history sociology and women's studies at all levels
